## **Understand the Meaning of Argumentative Essay**

#### **Follow Five Parts Format**

Whether you are making an outline or draft for your argumentative essay, it is better to follow five parts formats. It means there should be an introductory paragraph followed by three paragraphs for the body section in which all data, examples, and evidence will be used to prove the thesis statement. While the remaining paragraph will be conclusion.

Here you should know that if your essay is lengthy and requires more data, then the number of paragraphs can be increased.

## Things That You Can't Miss

While filling your five parts format with the information, you should not forget a few essential things. First is the hook. In the introduction paragraph, add-hook in the form of quote, story, or question to generate the interest of the readers. Second, include background so that readers can understand the reason and previous information about the topic.

The third is the thesis statement, that is the real essence of the argumentative essay. The thesis statement should be precise and concise. Last but not least, always add the outcome of the essay so that readers can know what they will learn after a complete reading of your argumentative essay.
